This is to inform you of the process that is needed to have elections on the utahassembly.org website.

- 1. If you DO NOT have an account then -
- 2. You will need to go to the website and in the menu hover on the "Public" menu and then click on "UA Sign Up".
- 3. Fill in the blanks with your information. Email address is a must if you want to participate.
- 4. Make sure you enter your County as the election program will handle County elections as well as State-wide elections.
- 5. Your account for the website will be validated by website Admin. As long as you have had your paperwork for being an American State National at least.
- 6. Once your account is validated you can Sign-In to the website.
- 7. If you already have an Account then just Sign-In.
- 8. When there is an election you can Sign-In to the website and the "County Elections" menu tab and the "State Elections" menu tab will be available.
- 9. You will be able to view the current election of American State Citizens to any of the State or County Offices.
- 10. You can select either "Yes" or "No" for any and all existing nominations that are being proposed.
- 11. Once you have Clicked on your choice the program will save that record in the database. THAT IS YOUR RECORD! It belongs to you and only you.
- 12. The program will send you an email of the proposal/nomination with your choice of either "Yes" or "No".
- 13. A carbon copy (cc) of that email is sent to the The Utah Assembly Elections Clerk and Recorder.
- 14. Now you can Sign-In to the website and view you past voting record.

- 15. The office of The Utah Assembly Elections Clerk and Recorder is occupied with only those who are ASCs and have an Affirmation of Honor like any other office for The Utah Assembly.
- 16. This would be subject to a specific common law of operation.
- 17. This office would be subject to Grand Jury investigation with indictment, trial, judgement and punishment by a common law jury of 12 impartial jurors.
- 18. An over-site committee of at least 3 active ASCs needs to be appointed to oversee the elections. (Election Committee)
- 19. Any discrepancies between your election email and your record on the website database will be investigated by The Utah Assembly Elections Clerk and Recorder Office.
- 20. If any discrepancy is detected on your end between the email and your record on the website database you must contact the Office of The Utah Assembly Elections Clerk and Recorder Office and they will begin investigation.
- 21. The Utah Assembly Elections Clerk and Recorder Office will process the investigation. Protocols need to be established.
- 22. Notification will start just after nomination(s). The Election process will be open by computer until midnight Friday before the Assembly meeting. Secret ballot Election will be open for one hour at the beginning of the Assembly meeting. Election results will be announced at the meeting of the Assembly.
- 23. Candidates must be present in the Assembly meeting, either by Zoom or in person, to accept the nomination.
- 24. Candidates have the option of presenting a Bio of themselves with picture (if desired) and having it posted in an Assembly wide email.

FYI: The process of elections in the de facto government does not connect your vote to you. This is where the weakness is. The Utah Assembly Elections is accountable to We the People of Utah.

Having a record that is tied specifically to you in the database offers higher security to the elections process.

To increase the security on the utahassembly.org website it is recommended that The Utah Assembly purchase a "Secured Socket Layer" i.e. (<a href="https://www...">https://www...</a>) as opposed to (<a href="http://www...">http://www...</a>). This runs around \$50 to \$100 a year. That needs to be verified.

Procedures for Elections and Voting on Motions in The Utah Assembly.

Voting on Motions.

When voting on Motions All ASNs and ASCs can participate to make their voice be known either in person or on the Zoom meeting. No secret ballots needed.

A Motion must be proposed and then seconded by another ASN/ASC. Discussion to follow.

Those present at the meeting and those present on Zoom will have their votes tallied by the Elections Clerk and Recorder or an appointed member by the Elections Clerk and Recorder or a member of the Elections Committee.

If a Motion is deemed to be critical to ALL ASNs then it may be presented for the next Assembly. \*Optional.

## The Utah Assembly **Rules of Conduct** for Public Meetings Oct 11, 2021

Order of electing and introducing New Business. a motion must be made to introduce new business, or to elect a member in good standing to the office as an elector.

1<sup>st</sup> motion must be made, name and county. 2<sup>nd</sup> motion must be made, name and county.

Nays to be taken, abstentions noted, all in favor say Aye, the results noted.

Election or appointment requires 75% approval as per Anna's article 3020, Roll call Vote. 75% of attendees need to vote "aye" (abstaining is not an "aye," and it must be 75% of attendees).

Failure to meet the 75% quorum set as Public Law precedent, a cool-off period of 45 days takes place for re-run if a member chooses to do so.

All members electing need to be in Honor, must meet duly agreed upon standards set by The Utah Assembly - all 928 and additional documents verified as recorded prior to election. If all documents not in place on day of election, must wait 45 days to re-run, if they choose.

Members seeking election to Public offices must have following paperwork completed: 1779 Declaration, Two witness attestations, Birth Certificate, 928 package, Attestation and Affirmation of Singular Loyalty in the Form of an Affidavit, Attestation of Exemption and Immunities, and Bio presented for review by members and background checks returned to coordinator.

All paperwork must be on file with The Utah Assembly prior to running for election.

Recall of sitting Public Official- If malfeasance or ineligibility can be proven by two or more witnesses, of a seated Public Official, a recall may be called by special session, 90% vote of seated Assembly must elect to recall/remove an Official.
